The CORE Center is the flagship infectious disease outpatient primary and specialty care center for the CCH System. It serves as the hub of HIV and Viral Hepatitis care, STI/HIV prevention and care, and together with five other ambulatory health centers, anchors sexual health services within the CCH system. Management responsibilities include oversight of a multidisciplinary staff of more than 200 professionals, daily clinical operations for HIV primary and specialty care, fully integrated with behavioral health and oral health care, multiple other specialty services, a walk-in STI/HIV screening clinic, along with a robust research portfolio, inclusive of biomedical and behavioral clinical trials and interventions. All of these designated sites conduct various support group sessions for patients; provide community-based and clinical site HIV education and testing; with active community advisory boards, including patients as trainees, volunteers and as staff members.

Budgetary responsibility includes oversight of multiple governmental and non-governmental programmatic grants, along with the CCH CORE Center annual budget, in efforts to assure that comprehensive services are continuously made available to all patients served. Facility management, grants management and personnel management through team building are all responsibility components, along with the programmatic and organizational effort to build comprehensive sexual health services throughout the CCH system.

The Office of Research & Regulatory Affairs regularly conducts training sessions and continuing education in research ethics, emphasizing best practice with vulnerable populations, inclusive of adult and juvenile detainees, for employees, multiple health profession trainees, medical residents, interns and students.
